Pablo Muñoz has served as the Superintendent of Schools for the Passaic Public Schools in New Jersey since October 2013. Throughout his tenure in Passaic, he has led significant systemic change with the goal of creating a great school system.

Muñoz led a complete district rezoning and realignment across the PreK-8 schools. He led the district to acquire critical spaces that added 44 new classrooms to the district, reducing the severe overcrowding. Muñoz created and opened 3 new schools in 2015, the Passaic Gifted and Talented Academy; and in 2018, the Passaic Preparatory Academy and the Passaic Academy for Science and Engineering.

He has also worked to ensure that instructional programming shifted to increase student engagement through cognitively challenging curricula. He has led a commitment to providing every student the

opportunity to graduate high school with 15 college credits and/or a career certification. This has resulted in an Early College program that has led to dramatic increases in Advanced Placement and dual enrollment college course offerings.

As a first-generation high school and college graduate, Muñoz's personal experience fuels his passion for creating high quality school systems. He graduated from Elizabeth High School, Elizabeth, NJ in 1987 with academic and athletic merits, including All-State selection in baseball. He continued to excel at Yale University, graduating with a bachelor's degree in Psychology and Ivy League pitching honors. He graduated college passionate about supporting students, and began his career at Elizabeth High School as a teacher of social studies. In addition to his role as a teacher, Muñoz continued his studies at Teachers College, Columbia University, where he earned a master's degree in Educational Administration. He has served as Supervisor, Director, and Assistant Superintendent, before becoming Superintendent of Schools in the Elizabeth Public Schools in May 2005.

Dr. Timothy Sullivan grew up in Brooklyn, NY, where his grandparents eventually settled. His Irish grandparents immigrated to New York City as teens around 1905 – his grandfathers were dockworkers and eventually firefighters and his grandmothers served as domestics until marriage. His father was a New York City policeman who did not go to college, his mother was disabled, and he grew up in a large ethnic household without much money (his family qualified for the free lunch program when it came to his school in the late 1950s). When Tim entered Yale, it was just beginning to accept students from nontraditional and low-income backgrounds. For him, Yale was a culture shock, and although it was clear that he did not fit in, Tim loved ideas and realized that this was a great opportunity for him. He went on to spend summers as a postal worker to help pay for school and did bursary work during the academic year. He majored in mathematics but found himself more interested in philosophy and government.

During his early days in New York, the banning of apartment incinerators, coal, and high sulfur oil improved air quality dramatically and attracted Tim to the then emerging environmental and energy policy. He applied to Harvard's Kennedy School of government, and studied energy and environmental policy, earning a Masters' Degree in 1976 and his Ph.D. in 1980. By the end of the Yale-Harvard experience, Tim felt that he did not fit into the community of his birth, but did not feel like a Yalie either. In 1980, he shares, California was a place to reinvent oneself, and after a brief time in Washington, D.C. he moved to California in 1981 and eventually had a career at the California Public Utilities Commission, working on energy, telecommunications, and environmental policy. Eventually he became Executive Director of the State Agency during Governor Brown's second administration, and worked on changing the organizational culture and expanding the mission to include greenhouse gas reduction and to reduce safety threats from the electric and gas infrastructure, particularly wildfires.

At this time, Tim feels very connected to Yale and knows that there are now many more students taking the FGLI path. Tim is now very grateful for the chance he had (which, he shares, was not always the case). His daughter attended Yale ("It is a shock to be related to a legacy"), and through her he has met students who were also the first in their families to go to college. Dr. Sullivan and his daughter shared some of his experiences with these students, and he has come to realize that just being able to talk with someone going through similar transitions can be helpful. During Tim's time at Yale, is was difficult to find people with the FGLI experience, and no one discussed it.
